Our vision

Rising stars day nursery will consistently provide excellent levels of care and education for each child. We excel in creating a home from home environment so the children can feel safe, secure, and nurtured. Our enthusiastic, motivated, and highly qualified staff team will aim to provide a stimulating learning environment to reach all children's full potential through the love of learning.

Our Day

We want your child to enjoy their experiences at Rising Stars and appreciate that every child is an individual and this will be reflected in the care they receive.

All the children will have an opportunity to take part in a range of planned activities which reflect the appropriate curriculum as well as including all aspects of children's learning.

There will be a chance for the children to lead their own play and this is supported by the trained staff, child friendly storage and

accessible equipment. There is a comfortable rest area in each room which allows your child to have quiet time to sleep or relax.

All sleep and rest time are fully monitored by a member of the team.

All the rooms have plenty of space to play enabling each child to get the most out of the activities provided, such as dancing, circle games and large construction equipment.

There is a messy play area where there will be creative activities, baking, sand and water play, as part of any child's learning is exploring and experimenting with different materials.

Your child will play outdoors at least twice a day, children love playing in all weathers and whether its puddle jumping or enjoying the sunshine your child will have regular opportunities to enjoy the fresh air.

OUR ROOMS



Comets

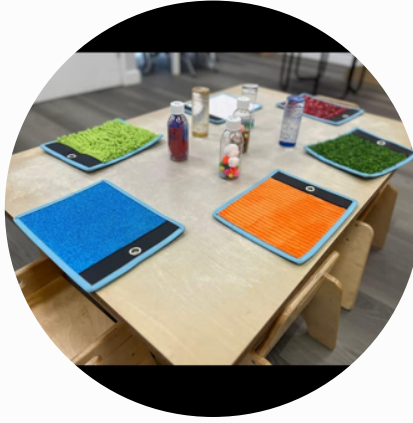
Comets room is for children aged 12 months to 3 years.

The ratio in this room is 1:4 for 2-3.

Staff will work along side the room lead to create exciting activities, following the children's individual interests.

Creative activities, sensory play, construction, puzzles, books, mark-making, sand and water play are just some of the activities the children enjoy.

We have access to a secure garden with lots of equipment to enhance their physical development, as well as a mud kitchen for some messy cooking.



Rockets

Rockets is our preschool room. The ratio in this room is 1 adult to 8 children

We provide a variety of play-based activities, including small world, table top games, sand and water play, sensory and creative, role play and construction and, of course, books.

Letters and sounds are introduced in a fun way, building the foundation blocks of literacy.

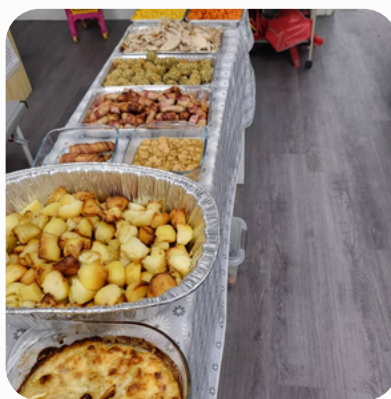
The children have a Key Person who works closely with them extending their knowledge and moving them on the the next stage of learning.

Circle time offers many opportunities for the children- we talk about our book of the month, learn the sign of the week and encourage the children to share experiences with their peers.

Delicious Meals

At Rising Stars all of our meals are cook daily on the premises. We have a 4 weekly menu offering well balanced meals and snacks. All specific dietary requirements are catered for and we are increasingly catering for children with specific food intolerance's and special dietary needs.

Supported family funding

Those in receipt of government support may be able to get additional help towards the cost of their childcare fee's or be entitled to 2-year funding. You can find out more about this on the government website.

You can access your funding across 1 full day (8am – 6pm) and 1 half day (8am – 1pm/1pm – 6pm)

You can access this across 38 weeks of the year, we do not stretch funding across 52 weeks. No charge is applied to your account for families receiving this type of funding.

24 hours' notice must be given to cancel an extra session, or fees will still be charged.

Days/session cannot be swapped for another day.

Extra sessions need to be booked in advance.

A minimum of 2 full day sessions or 3 half days attendance is required per week.

Fees are based on 52 weeks per year & divided over 12 equal payments.

Late payment of fees may incur an additional charge

4 weeks written notice is required to cancel or reduce any sessions

Where Term Time only placements are offered at your setting, these are limited. Please speak to the Nursery Manager for further information.

If you are in receipt of goverment funding, we require a minimum of 20 hours to be claimed at Rising Stars

Extra sessions are available on request, charged at the same rate. Subject to availability.

Discounts: 5% Eldest Sibling Discount, 10% Full Time Discount

The nursery will close at 1pm on 24th December (Xmas Eve

Fees are calculated evenly over 12 months. However, once your child's final funded term ends, any sessions attended beyond this date will be charged at the standard full rate.

For example, if your child is due to start school in September, their government funding typically ends in the third week of July. Any sessions attended after this point will not be covered by funding and will be charged at the usual rate.

Sessions, Fee's, and Funding Explained

ADMINISTRATION FEE/DEPOSIT

- When you request a space at Rising Star's you will be required to pay a deposit of £100. Once we have received this payment it will guarantee your child's space at Rising Star's. Settle sessions and completion of paperwork will not be arranged until the deposit has been paid.
- 75% of your registration fee will be refunded when your child ends their Rising Star's Journey, subject to 1 months notice being given and any outstanding fee's are paid in full.
- If you need to defer your child's start date for any reason, you would be required to request this in writing. We can not guarantee that we would be able to accommodate changes as our occupancy is completed well in advance.
- If you decide at a later date not to take up your space at Rising Stars, the deposit will not be refunded.

FEE'S

- You will be sent an invoice between the 20th and the 25th of each month, this invoice is to be paid on or before the 1st of the following month.
- You will receive your first invoice at least 7 days before your child's start date. This must be paid in advance of your child starting.
- If your child join's part way through a month, your first invoice will be for the remainder of the month.
- We close for the period between Christmas and new years and all bank holidays
- You will still be charged for sickness and family holidays
- Our fee's are worked out equally over a period of 12 months. The sum we use is
- Session cost per week multiplied by the number of weeks in the year Divided by 12 monthly payments.
- If you need to make changes to your Childs sessions we need at least 4 weeks' notice. Changes can be applied immediately but you will still be charged the notice period.
- If your account falls into arrears, your child's space will be at risk. Late fee's may be applied to your account.

WE ACCEPT PAYMENT FROM THE FOLLOWING METHODS

- Tax free childcare - You can get up to £500 every 3 months (up to £2,000 a year) for each of your children to help with the costs of childcare. For every £8 you pay into your online account, the government will pay in £2. More information and eligibility information can be found at www.childcarechoices.gov.uk. If paying via tax free childcare please tell us your reference number so we can allocate payments to your account.
- Childcare voucher scheme – Although this scheme is closed to new applicants, if you joined a scheme before 2018 you can continue to pay via this method.
- Funding for children from 9 months - childcare if you're working you may be able to get free childcare for your child aged 9 months to 4 years old if you live in England. The amount of free childcare you can get depends on:
 - your child's age and circumstance
 - whether you're working (employed, self-employed, or a director)
 - your income (and your partner's income, if you have one)
 - your immigration status
- BACS – our banking details are included on the monthly invoice, please use your Childs name as a reference

GOVERNMENT FUNDING

- From September 2024 some children from 9 months may be eligible for funding from the government. The Government funding is intended to deliver 15 or 30 hours a week of free, high quality, flexible childcare. It is not intended to cover the costs of meals, other consumables, additional hours or additional activities. (see below).
- All children from the term after their third birthday are eligible for up to 30 hour funding. Visit childcarechoices.gov.uk for more information.

Sessions, Fee's, and Funding Explained

ADDITIONAL COSTS

- Our inclusive care cost is for all the essentials like food and toiletries, along with those enriching extras the government funding isn't meant to cover. Like most nurseries, we'll ask you to contribute towards them if your child is in receipt of funding we charge £2 per hour. These include :
- Our freshly prepared healthy snacks in the afternoon, along with a meal for those little ones with us at breakfast, lunch and tea time.
- Cleaning and care materials, including nappies, wipes, toilet rolls, soap and paper towels.
- Our blossom parents app, where you receive a daily diary, photo updates during the day, observations and notices giving you a real time insight in to your little ones day.
- Our high quality care, and high staff to child ratios. This ensures we can have a more individual nursery experience with your little one and whole family which is so important to us.
- Extra curricular activities, such as local trips, crafts, cookery, experiences, celebrations and much more
- Regular sessions with Tiny Mites who come into the setting every 2 weeks to do yoga, dancing, etc with all of the children.

There are some exceptions of having to pay the inclusive care cost,

- Supported family funding, We recognise the importance of supporting families who are eligible for this funding, Therefore there are not additional costs for attending if your family is in receipt of certain government support benefits until the child turns 3 years old
- Our sessional fee's are already inclusive of the cost, so there is no additional cost.

SESSIONS

Rising Stars offer the following sessions-

- Half Day – Start at 8am and end at 1pm or Start at 1pm and end at 6pm.
- Long Day - Start at 8am and end at 6pm
- School Day-Starts at 8:30 and ends at 3:30 (available at Markyate setting only)

We offer an early bird start which starts at 7:30am and costs an additional £5 per day

BANK HOLIDAYS/CHRISTMAS CLOSURE

Like most other day nurseries fee's at Rising stars are payable for bank holidays and christmas closure periods This is because during these periods our outgoings and expenses (wages, insurance, rent, bills, registration costs) still need to be paid. By doing this we are able to keep our session costs low.

DISCOUNTS

From time to time we offer special offers and discounts.

Our regular discounts are as follows

Sibling Discount 5% - The sibling discount does not apply to any extra sessions, registration fees or other fees incurred.

Commuter Discount 10%

Terms and Conditions - discounts are not offered on funded only hours, only one discount to be used at a time

Free Government Funding

Free childcare places and inclusive care costs at Rising Stars

You may have seen recently on the news that childcare settings must be more transparent on the way we offer our Childcare funding.

We charge no top up fees on your funded hours, so whether you claim 15 or 30 hours childcare they are totally free.

However, we do charge an inclusive care cost to all children. We have always tried to be as transparent as possible to explain what the inclusive care cost covers within the setting; we will go into a bit more detail below.

What we charge for?

We have a full time cook within the setting plus a kitchen assistant each day. They work together with our head chef (who covers all settings) to bring balanced, nutritious meals each day. We cater for all allergies, intolerances and preferences ensuring inclusion for all children. We have ingredients delivered twice a week so your children have the freshest meals possible.

- Cleaning and care materials, including nappies, wipes, sun cream, nappy cream, Calpol, soap and paper towels.
- Flexible childcare options and high adult : children ratio.
- Our blossom parents' app, where you receive a daily diary, photo updates during the day, observations and notices giving you a real time insight into your child's day.
- Our high-quality care, and high staff to child ratios. This ensures we can have a more individual nursery experience with your little one and whole family which is so important to us.
- Extracurricular activities, such as local trips, crafts, cookery, experiences, celebrations and much more.
- Graduation Celebrations – when your child leaves us to start their journey at 'big school' we always like to send them on their way with a party. Last year as well as buying gifts, certificates, and a framed photo for each of the children we hired a Party Bus to come to the setting for the children to play on and have lots of fun.
- Halloween events – We had a Halloween party and stay and play event, we supply all the decorations, extra activities, crafts, and gifts for the children.
- Mother's Day – We invited carers into the setting for a Mother's Day breakfast or stay and play. We supply a choice of pastries, cakes, and drinks to the parents as well as decorations and additional resources so your children can make lovely gifts for you all.
- Valentines Day – We had a Valentine breakfast or play sessions. We supply all the food, decorations and additional crafts and activities for your children to celebrate this event.
- Christmas Party – We put on an amazing party for all the children at Christmas. We buy each child a present, cover the costs of a visit from Santa, Christmas decorations, party games, party food and lots of fun.
- Tiny Acorns – We hold sessions every 2 weeks with tiny acorns who come into the setting. All the children can join in our fun-filled imaginative classes. Your children will be learning without even realising it ... they whilst having lots of fun!

We want to ensure that the childcare we offer is accessible to all families, so we do not charge consumables cost to families who are in receipt of supported family funding.

Admissions Policy

The numbers and ages of children admitted to the nursery comply with the legal space requirements set out in the Early Years Foundation Stage (EYFS). When considering admissions we are mindful of staff: child ratios and the facilities available at the nursery. The nursery use the following admission criteria, which is applied in the following order of priority: 1. Looked after children 2. A child known by the local authority to have special educational needs and/or a disability (SEND) and whose needs can be best met at the preferred nursery 3. A vulnerable child with either a Child Protection or a Child in Need Plan, or in receipt of other local authority support 4. Children who have siblings who are already with us 5. Children whose parents live within the area. A child requiring a full-time place may have preference over one requiring a part-time place. This is dependent upon work commitments, occupancy and room availability. We operate a waiting list and places are offered on an availability basis. We operate an inclusion and equality policy and ensure that all children have access to nursery places and services irrespective of their gender, race, disability, religion or belief or sexual orientation of parents. Prior to a child attending nursery, parents must complete and sign a contract and registration form. These forms provide the nursery with personal details relating to the child. For example, name, date of birth, address, emergency contact details, parental responsibilities, dietary requirements, collection arrangements, fees and sessions, contact details for parents, doctor's contact details, health visitor contact details, allergies, parental consent and vaccinations etc. Providers eligible to provide government funded places for early education All settings registered to accept government funding (detailed in the code of practice) must offer free places for two, three to five year olds for early learning sessions specified by the local authority. At Rising Stars we currently provide free funded places for children is subject to availability. These places will be allocated on a first come, first served basis and can be booked a term in advance. Please note for admissions for the free nursery education we have a termly intake, beginning the term following your child's second/third birthday. All funded sessions are now in line with the flexible arrangement as specified by the Government. When you register your child for their funded place we will discuss your needs and, as far as possible with availability and staffing arrangements, we will accommodate your wishes. We reserve the right to limit and/or have specific funded sessions, according to our business requirements.
